- ✓ If the test is positive, the Protocol for Suspicious Guests and Employees in the Enterprise is applied
- ✓ Positive case information ALO 184 line, relevant Provincial Health Directorates and Provincial Culture and Tourism Directorates are informed.
- ✓ Our guests, whose residence address is abroad, can have the covid19 test done at test centers, airports or accommodation facilities for a fee, if they request, they can be informed about the working hours of the test organization, the content of the test, its duration and the test result, and guests who have to have a covid-19 test on their return to their countries. In order not to be exposed to the intensity or the density that may be experienced, guests who have a positive result should have a test 48 hours before their journey, and the guests who have a positive result should immediately inform the management of the facility they are staying in and the information units at the airports. This information is included in the Guest Communication and Health Survey. In addition, written information was provided in at least two foreign languages, one in Turkish, at the entrance to the facility. The information letter contains the following two pieces of information.
- ✓ If guests want to have a test, they can access their name information from the Ministry of Health authorized diagnostic laboratories via the following link or a data matrix. In addition, if the guest requests, they can have a test from the private health institution that our facility has an agreement with.
